***From 95 North:*** Take 95 south to exit 1B (896 north, Newark) in Delaware. Follow 896 North through Newark (this road makes a few turns, please watch signs closely). Follow 896 North into Pennsylvania and continue to the second stop sign (go through the town of Kemblesville and into New London). At the second stop sign turn left onto State Rd. Go to the second stop sign and turn left onto Rt 472. Go past the 1<sup>st</sup> driveway on the left and you'll see signs for the trial just past the 1<sup>st</sup> driveway, on the left. Sign will read AHBA TRIAL You'll pull into what looks like a yard, please follow signs for parking.

***From 95 South:*** Take 95 North to exit 100 in Maryland (Rt 272) Go left at the top of the exit and take Rt 272 North. The 2nd traffic light is Rt 273. Cross over Rt 273 and take the 1st road on the right. (Lombard Road) Stay on Lombard Road (the name will change to State Road in PA) and go to the 2nd stop sign and turn right onto Rt 472. Go past the 1<sup>st</sup> driveway on the left and you'll see signs for the trial just past the 1<sup>st</sup> driveway, on the left. Sign will read AHBA TRIAL You'll pull into what looks like a yard, please follow signs for parking.

***From RT 1 North or South:*** Take the Jennersville exit, Rt 796 South. Stay on 796 south to you get to the first stop SIGN (not light). At the stop sign bear left onto Rt 896 south. Go to the 1<sup>st</sup> stop sign and turn right onto State Rd. Go to the second stop sign and turn left onto Rt 472. Go past the 1<sup>st</sup> driveway on the left and you'll see signs for the trial just past the 1<sup>st</sup> driveway, on the left. Sign will read AHBA TRIAL You'll pull into what looks like a yard, please follow signs for parking.

#### **GENERAL INFORMATION**

The correct money amount must accompany your entry form(s). Any Checks returned will be considered a void entry. There is a \$45 service charge for all returned checks. If entries are resubmitted fees must be paid in money order or cashiers check.

Entry fees will not be refunded is the show cannot open or be completed by reasons or riots, civil disturbance, fire and/or weather conditions, acts of God, public emergencies, acts of public enemy, strikes, or other causes beyond the control of Fly Away Field

Entry fees will not be refunded in the event that a dog is absent, disqualified, excused by a veterinarian or judge, or banned from competition by the Trial Committee or Course Director.

In the case of a dog injuring stock, dog's owner will pay all vet fees and/or replacement value of the stock (Sheep \$300, Ducks \$40) and/or any veterinary or disposal fees if required.

Each owner/handler is responsible for their dog(s). All dogs must be confined or on lead except when competing. Dogs are not allowed to run loose during the trial or after the trial without permission from the Course Director. There is a pond where people with permission will be allowed to swim their dogs and themselves.
