#### LEVEL ONE

All handlers and dogs enter through the blue gate at the small arena. Dog's leash must be removed prior to opening the red gate to begin course/time.

In the small arena start at the RED gate of the take pen. Dog and handler enter the take pen and proceed counter clockwise around the sheep, then exit pen, leaving sheep in the pen.

Open the gate. Handler and dog take sheep out of pen and fetch sheep to the silver gate. Taking sheep through the gate and turn left.

Begin the 50ft drive through the set of panels to the next set of panels. Proceed to the flagged area of the HTD field.

In the flagged area, begin a 2 minute graze. You will be alerted once the time limit has been reached.

Once graze is over, handler and dog retreat and position themselves at the cone. Handler may leave dog at the cone and position themselves half way between sheep and dog prior to sending dog for the gather. Handler must be standing still at the time of sending the dog on the outrun of the gather.

Handler may move after the lift and proceed toward the house and around the right side of the pine trees and turn left. Proceed to the back side of the pines down the lane way. Sheep may be fetched or driven, handler's call.

Stop the sheep at the cone in the lane way, before proceeding to the blue gate.

Open blue gate and drive the sheep down the right side of the cones to the stock trailer. Open the back door and load the sheep onto the trailer. Close the door. Open the door and remove sheep from the trailer. Level one may go into the trailer with the dog to help unload the sheep. Close the trailer door. Drive the sheep on the right side of the cones and back through the gate.

Once sheep have cleared the gate, proceed down lane way straight to the silver gate of the small arena through the set of panels and to the red gate of the barnyard. Take sheep and offer a drink of water at the tank by the side of the barn. Dog may take a dip in tank without penalty. Sheep may remain at water for 1 min, longer at the discretion of the judge without a time penalty.

Sheep are fetched and taken to the blue gate of the large arena. Any sheep that escape and go into the run in shed will be counted as off line. (sheep must actually break the plane of the doorway to be penalized)

After the sheep entered the large arena, turn left and take sheep the left side of the shade trees to the half maltese cross on the far side of the arena. Sheep must enter the left side to the maltese and go straight over the tarp then on to the pen.

Place all sheep into the free standing pen and close the gate. Remove the sheep out of pen.

Stop and hold sheep off the gate for 30 seconds then re-pen the sheep.

#### LEVEL TWO

All handlers and dogs enter through the blue gate at the small arena. Dog's leash must be removed just inside the blue gate to begin course/time.

In the small arena, the RED gate of the take pen is the start. Dog and handler enter the take pen. Handler remains at the gate and directs the dog to counter clockwise around the sheep, then dog exits pen, leaving sheep in the pen.

Open the gate. Handler and dog take sheep out of pen and fetch sheep to the silver gate. Taking sheep through the gate and turn left.

Begin the 50ft drive through the set of panels to the next set of panels. Proceed to the flagged area of the HTD field.

In the flagged area, begin a 2 minute graze. You will be alerted once the time limit has been reached.

Once graze is over, handler and dog retreat and position the dog at the closest set of panels prior to sending the dog for the gather. Handler may move to the cone. Handler must be standing still at the time of sending the dog on the outrun of the gather, and remain at cone until lift.

Handler may move after the lift and proceed toward the house and around the right side of the pine trees and turn left. Proceed to the back side of the pines down the lane way. Sheep may be fetched or driven, handler's call.

Stop the sheep at the cone in the lane way, before proceeding to the blue gate.

Open blue gate and with handler remaining at the gate, drive the sheep down the right side of the cones to the stock trailer. Once sheep are half way to trailer, handler may leave gate. Open the trailer door and load the sheep onto the trailer. Once all sheep are loaded, close the door. Open the door and remove sheep from the trailer. Close the trailer door.

Drive the sheep on the right side of the cones and back through the gate.

Once sheep have cleared the gate, proceed down lane way straight to the silver gate of the small arena through the set of panels and to the red gate of the barnyard. Take sheep to barn and offer a drink of water at the tank by the side of the barn. Dog may take a dip in tank without penalty. Sheep may remain at water for 1 min. longer at the discretion of the judge without a time penalty.

Sheep are gathered and taken to the blue gate of the large arena. Any sheep that escape and go into the run in shed will be counted as off line. (sheep must actually break the plane of the doorway to be penalized)

After the sheep entered the large arena, proceed to the free standing pen, sort any 5 sheep into the free standing pen.

Take the remaining sheep and fetch/drive to the half maltese cross on the far side of the arena. Sheep must enter the north side to the maltese and exiting the south end once they have passed over tarp. Handler may not move past the north opening of maltese until all the sheep have exited the south end.

Return to the free standing pen and remove those sheep to rejoin the group.

Stop and hold sheep 30 seconds off the gate. This must be accomplished in the area between the free standing pen and the re-pen gate.

#### LEVEL THREE

All handlers and dogs enter through the blue gate at the small arena. The leash must be removed just inside the blue gate to begin course/time.

In the small arena, the RED gate of the take pen is the start. Dog enters the take pen. Handler remains at the gate and directs the dog to counter around the sheep, taking sheep out of pen.

Open the gate. Handler and dog take sheep out of pen and fetch sheep to the silver gate. Taking sheep through the gate and turn left.

Begin the drive through both sets of panels to the flagged graze area in the HTD field.

Once at the flagged area, begin a 2 minute graze. You will be alerted once the time limit has been reached.

Once graze is over, handler and dog retreat to the cone closest to the pine trees prior to sending the dog for the outrun.

Handler may move after the lift and proceed toward the house and around the right side of the pine trees and turn left. Proceed to the back side of the pines down the lane way. Sheep may be fetched or driven, handler's call.

Stop the sheep at the cone in the lane way, before proceeding to the blue gate.

Open blue gate and with handler remaining at the gate, drive the sheep down the right side of the cones to the stock trailer. Once sheep are settled to trailer, handler may leave gate and proceed to trailer. Open the trailer door and load the sheep onto the trailer. Once all sheep are loaded, close the door. Open the door and remove sheep from the trailer. Close the trailer door. With handler standing at the trailer. Drive the sheep on the right side(north side) of the cones and back through the gate. Dog holds sheep at the gate until handler opens.

Sheep are to proceed down lane way straight to the silver gate of the small arena are driven through the set of panels and to the red gate of the barnyard. Take sheep to barn and offer a drink of water at the tank by the side of the barn. Dog may take a dip in tank without penalty. Sheep may remain at water for 1 min. longer at the discretion of the judge without a time penalty.

Sheep are re-gathered and taken to the blue gate of the large arena. Any sheep that escape and go into the run in shed will be counted as off line. (sheep must actually break the plane of the doorway to be penalized)

After the sheep entered the large arena, proceed to the free standing pen, sort the *marked* 5 sheep into the free standing pen.

Take the remaining sheep and drive to the south end of the half maltese cross on the far side of the arena. Sheep must enter the south side to the maltese and exiting the north end only after they have passed over tarp. Handler remains at the free standing pen.


Handler may leave the free standing pen and walk to the shade trees.

After sheep have cleared the maltese, the dog fetches the sheep to the south side of the shade trees and held for 1 min.

Return to the free standing pen and remove the penned sheep to rejoin the group.

Stop sheep and preform a shed. This must be accomplished in the area between the free standing pen and the re-pen gate. At least 30 feet from the gate.

Repen all the sheep.



#### NOTICE TO EXHIBITOR:

ALL DOGS MUST BE ON LEAD, unless on course while being judged. PLEASE do not allow dogs to harass the LGD or stock. Dogs may only wear a plain buckle or snap-lock type collar(no tags) or may work without collar at trial levels while being judged.

#### PLEASE CLEAN UP AFTER YOUR DOG AND YOURSELF.

Separate entry form MUST be submitted for each dog.

Entries are filled, first come, first served basis. In the event classes fill, there will be a waiting list. Entries will be placed on waiting list unless a note is included stating entrant does *NOT* wish to be wait-listed. You will *only* be notified of position of entry, if you specifically ask to be emailed and included such contact information. Changes to entry must be made in writing or email prior to the close of entries.

Entry fee will not be refunded in the event that a dog is absent, disqualified, excused by the judge, or barred from competition by action of the test/trial committee. Entry fees will not be refunded if the test/trial cannot open or be completed by reason of riot, civil disturbance, fire, or act of God, public emergencies, act of public enemy, strike or any other cause beyond control of the sponsor.

RETURNED CHECKS do not constitute a valid entry fee. If a check is returned, fees must be paid in guaranteed funds; checks will not be accepted as a replacement. The Secretary will add a collection fee to the amount of each returned check.

#### Directions:

#### From North (Rochester Area)

Take 390 South to Exit 9. From Ramp turn Left onto State Route 15 south into Lakeville. At the light, bear slightly to the left(do NOT take immediate left)you will drive in front of Pizza Paul's. Follow Rte 15 to the next traffic light. Make a right on to East Lake Road. Travel approx. 6 miles to make a left on to Holmes Hill Road(the second road past the State Boat Launch) travel approx 1 mile to Turkey Hill Road, make a right. Go EXACTLY ½ mile. Look for Zig Zag wooden fence and Wind Over Woods sign.

#### From the South.

Take 86N, which becomes, 390N. Exit 3(Wayland), turn right on to State Route 15N. Travel through the village of Wayland to Springwater. At the flashing light in Springwater, turn left and follow 15N through Webster's Crossing and through the Hamlet of Conesus. Follow 15N to Rowland Road, which will be the third road on left past the Fire Dept. Turning left on to Rowland Road. Follow to the end(exactly 1 mile) *It is in your best interest to come to a COMPLETE stop at the stop sign by the dairy farm.* At the next stop sign, you are facing a wooden Zig Zag fence. You have reached your destination. Driveway is to the left.
