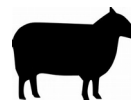
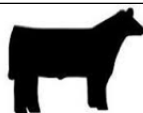

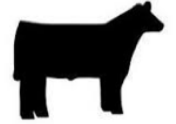

# GROUND RULES



Dogs must be ready for judging. Neither the Club nor the Course Director will be responsible or obligated to furnish any services for notifying exhibitors or their agents of class judging. Bitches in heat run at end of their entered division. Entry fees will not be refunded in the event a dog is absent/no show, disqualified, excused or barred from competition by action of the trial committee or judge, handler does not think dog is ready or pulling dog after entry date close, or if the trials can not be opened or completed by reasons or riots, civil disturbances, fire, Acts of God, or public emergency.

The club sponsoring these events, the course director, their agents, officers, club members and or committee shall assume **NO RESPONSIBILITY** for injury to you or children or dogs. **YOU ENTER AT YOUR OWN RISK.**

All dogs must be leashed or crated at all times except when competing. No flexi-leads allowed. No un-entered dogs allowed. No electrical and or mechanical training devices will be permitted on the trial grounds.

Please clean up after your dogs, failure to do so could result in you being dismissed or barred from the trial grounds and competing.

All dogs must have current vaccinations for rabies, distemper, parvo, bordetella - please bring a copy of rabies certificate or current tags with you. A signed liability consent and release waiver will be required for entry to the grounds & trials.

There will be **NO** use of cameras, phone, video allowed unless expressed permission from the Course Director.

These trials are held on private property, which is a working Farm. You must obey all Farm Rules.

Children must be accompanied by & kept under the direct supervision of an adult at all times.

Belle Meadow Farm, the Gavin/Kasser family is **NOT RESPONSIBLE** for any damage, injuries, trauma, losses, etc that may occur while you are on the property.

Please vacate the premises upon completion of the **TRIALS** each day per **CMBTASC** Insurance policy.

NOTE: ONLY CLUB DESIGNATED STOCK WRANGLERS & THEIR DOGS WILL BE ALLOWED IN THE PENS & WILL SET OUT STOCK
