**Friday Post-Advanced Only:** Trial 1 – Cattle & Sheep/ Rick Hardin; Trial 2 – Cattle & Sheep/ Tony Padgett  
Course: Cattle (3 head) & Sheep (5 head) Post-Advanced Course A.  
We will run Trial 1 Cattle, Trial 2 Cattle, Trial 1 Sheep, Trial 2 Sheep.

**Saturday Arena Trials:** Trial 1 – Cattle & Sheep/ Rick Hardin – Ducks/ Tony Padgett  
Trial 2 – Cattle & Sheep/ Tony Padgett – Ducks/ Rick Hardin  
Course 8+s: Cattle (3 head) & Sheep (3 head) Course E left-hand chute with a gather;  
Ducks (5 head) Course H with a gather, counterclockwise

**Sunday Arena Trials:** Trial 1 – Cattle & Sheep/ Tony Padgett – Ducks/ Rick Hardin  
Trial 2 – Cattle & Sheep/ Rick Hardin – Ducks/ Tony Padgett  
Courses: Cattle (3 head) & Sheep (3 head) Course H with a gather counterclockwise;  
Ducks (5 head) Course H with a gather, counterclockwise

**Saturday and Sunday: Trial 1 Ducks will run concurrently with Trial 1 Cattle.**

## ENTRY INFORMATION:

**By postmark:** Pre-entries open for **Aussies only** on **Monday, 10/25/21**; **All other herding breeds**, pre-entries open **Friday, 10/29/21**. Pre-entries close on Saturday, 11/06/21.

**No overnight, phone, or email entries.** Entries will not be accepted without payment. A wait list will be maintained. No refunds after the closing date unless runs can be filled from the wait list.

**Post Advanced Trial Fees:** Cattle - \$60, Sheep - \$50; **Arena Trial Fees:** Ducks - \$35, Sheep - \$45, Cattle - \$55, Junior/Novice - \$20 per class

**Special Pre-Entry Packages:** Both post-advanced trials (Friday) \$190; All 4 arena trials all stock (Sat/Sun) \$460

Trial site opens at 7 AM. Handlers' meeting at 8 AM each day. Day-of entries will be taken at 7:30 AM each day, if runs are available. Additional \$5.00 per class for day-of entries (if available).

**COVID-19 STATEMENT:** All State and Local COVID-19 regulations will be followed. Per ASCA's guidelines, competitors showing any symptoms or with relatives showing symptoms must stay home and not participate in events. People who test positive or have relatives who test positive for coronavirus should follow state and local quarantine rules. Entry fees will be refunded for any COVID-19 related cancellations.

**POLICIES:**

- This trial shall be run under all ASCA rules and regulations. See [asca.org](http://asca.org) for current rules.

- Non-ASCA registered dogs – To have ASCA qualifying legs tracked and receive ASCA titling certificates, each non-ASCA registered dog will be required to have an ASCA Tracking Number. This is a one-time fee of \$10 per dog. At the time of application for the tracking number, the individual owner must also be an ASCA member (minimum membership type, the Service membership, is required). - Each individual is responsible for any damage caused by himself, his family or his dog while in the trial arena or on the trial grounds. Livestock replacement costs are as follows: Ducks - \$75, Sheep - \$350, Cattle - \$1,200. ASCA, WAV, and Keepstone Farm assume no responsibility for any accident or injury.
- Substitutions allowed per ASCA Stockdog rules.
- Bitches in season will run in order. They should be crated away from trial arenas when not competing.
- All dogs must be on leash when not competing. Please clean up after your dog.
- Entry confirmation will be sent by email. Please include a legible email address.
- Trial committee will draw run order prior to the trial.
- Entry fees will only be refunded if request is received before pre-entry closing date or if runs can be filled from a wait list.

**AWARDS** (including but not limited to): Ribbons for all qualifying runs. Ribbons for 1st - 4th place, each stock, each trial.

Arena Trials: Rosettes for HIT Aussie, HIT Other Breed, HIT Started Aussie, and HIT Open Aussie.

Special Rosette for any dog completing a WTCH.
