Two Arena Trials Each Day - will be an AM and PM trial each day

One Farm Trial Saturday only – will be held after the PM duck arena trial ends.

Limited to no more than 50 runs per trial/farm combined, and all classes of stock combined

Ducks – runners and runner crosses

Sheep – Katahdin and Katahdin crosses

ENTRIES - PRE-ENTRIES open (postmark): May 24

Pre-Entries close July 1. Entries postmarked after closing date will be taken at Day of rate. Day of trial entries will be taken if the trial is not full.

All entries must have a postmark. NO hand delivered entries accepted. Entries must be made on the official ASCA entry form.

REFUNDS: If a trial fills, a waiting list will be maintained. No refunds will be made unless that entry can be filled from the waiting list. Entry fees will be refunded only when a dog has been certified by a licensed Veterinarian as unable to compete due to sickness or injury. Owner will be responsible for all vet fees. Dogs may be substituted if owned by the same person.

COVID-19 INFORMATION

- You were exposed to COVID-19 within the 14 days preceding the trial and do not have confirmed negative result from testing done after the exposure.
- You have COVID-19 or any of its symptoms at the time of the trial, or feel ill in any way during the trial.

GENERAL INFORMATION

The trial will be run and judged under ASCA rules as published in the most current rulebook. Run order will be drawn in advance. Bitches in season will run in order. All non-ASCA registered dogs must have an ASCA tracking number to receive ASCA titles. See <https://www.asca.org/> or call (979) 778-1082

Run Order will be drawn before trial.

Dogs must be confined or on leash at all times when not working or in a designated exercise area. Individuals are responsible for any damage done to stock and/or facilities. Dogs that attack or maul any person, dog or livestock will be disqualified.

RUNNING ORDER OF TRIALS

Saturday: Arena AM ducks will start first and sheep will start 15 minutes later

Arena PM will start 15 minutes after AM trial ends.

Farm trial handlers meeting will start 15 minutes after the conclusion of the PM ducks

Sunday: Arena AM sheep starts first and PM ducks will start 15 minutes later and before AM ducks.

Running order is subject to change and will be announced in the final confirmation

STOCK REPLACEMENT FEES: \$35 per duck, and \$300 per sheep. Owner of dog will be responsible for any veterinary expense to the stock.

DIRECTIONS FOR 7393 Corby Rd Honeoye Falls, NY

NYS Thruway Exit 46 (for I-390 South) from the north, east or west

Follow 390 S to the Rush Exit Turn left onto 15 South to the intersection of 251. Turn left to 251 east.

Then turn right at stop light onto 15A south. Follow 15A south to Corby Rd and then turn left. Farm will be on your left.

Coming from the South - I-86 to I-390 North

Follow I-390 North to Avon Exit – Exit 10. Turn right onto 20 E and then turn left onto Heath Markham Rd. Cross over 15A onto Corby Rd. Farm will be on the left in .3 of a mile

Housekeeping:

- Garbage cans are available for trash and dog waste
- Please clean up after your dog
- All gates must be kept closed if they were closed when you came through
- Please keep dogs on leash while on the trial site
- Please adhere to the off limits rules
- Bring your own chairs and canopies- limited shade at Cherry Hill Training Center
- Smoking in vehicles only
- Park in designated areas only

PEN-NY ASC Duck Farm Trial

Time: Open - 20 minutes / Advanced – 18 minutes

Warning – 10 minute warning for Open and 3 minute warning for both Open and Advanced

Ties: Broken on Sort score then on Gather score

1. 5 points (PEN)- Starts when the take pen gate is opened. Take all 5 ducks from take pen and settle them in the front of the pen. Task ends when ducks settle and team leaves the ducks.
2. 20 points (GATHER)- Starts when leaving the ducks after the take pen. Take dog to cone 75 ft. from pen. Open may leave dog and go half way to ducks. Advanced must send dog from their side. Once the dog is sent, all handlers may move anywhere. Dog will fetch/drive them to the back of the arena. Task ends when ducks are at the back of the arena.
3. 20 points (SPECIFIC TASK)- Starts when leaving the ducks are at the back of the arena. Bring ducks to hula hoop and hold them. Open handlers must hold at least 3 ducks in the hoop. Advanced handlers must hold all five. The judge will call a hold. Task ends when judge calls hold.
4. 5 points(PEN 2)- Starts when moving ducks from hoop to Pen 2. Move ducks from hoop to Pen 2 and close gate. Task ends when gate is closed.
5. 5 points(PEN 3)- Starts when gate opened to Pen 3. Move ducks to Pen 3 and close gate. Task ends when Pen 3 gate is closed.
6. 20 points(CHUTE)- Starts when Pen 3 gate opens. Move ducks from Pen 3 into 8 ft chute and visually inspect and spray for lice. Task ends when last duck clears the chute.
7. 25 points(SORT)- Starts when last duck clears the chute. Take all 5 ducks to Sort Pen and sort 3 ducks into pen. Open handlers may sort either into the pen or out of the pen. Task ends when the sort is complete and gate shut.
8. 5 points(PEN 4) Starts when gate is open from Sort Pen. Move ducks from Sort Pen to Pen 4. Task ends when all ducks in Pen 4 and gate closed.
9. 20 points(SPECIFIC TASK)- Starts when gate to Pen 4 opens. Take ducks from Pen marked 4 and drive/fetch to Foot Bath. Ducks can enter/exit from either side. Open handlers can move anywhere. Advanced handlers must stay behind designated handler's line until all ducks go through the bath.
10. 5 points (RE-PEN)- Starts when last duck clears the foot bath. Move ducks from foot bath to exhaust pen and let them settle then reopen them. Task ends when all ducks are re-penned and gate closed.
