“Day of” entries will be taken from 7:00AM until 7:30AM each day if space available

Entries will not be accepted without payment. \$25 charge for returned checks

Junior / Novice - \$20.00 per class

Additional \$5.00 per class for same day entries.

Refunds will not be given after the closing date unless runs can be filled from a wait list.

POLICIES:

- This trial shall be run under all ASCA rules and regulations.
- Non-ASCA registered dogs – In order to have ASCA qualifying legs tracked and to receive ASCA titling certificates, each non-ASCA registered dog will be required to have an ASCA Tracking Number. This is a one-time fee of \$10/dog. At the time of application for the tracking number, the individual owner must also be an ASCA member (minimum membership type, the Service membership, is required). ASCA membership does not need to be maintained in subsequent years. For more information and applications go to <http://www.asca.org/Portals/0/trackapp.pdf>
- Use official ASCA Stockdog entry form <http://www.asca.org/Forms/StockEntry.PDF>
- Each individual is responsible for any damage caused by himself, his family or his dog while in the trial arena or on the trial grounds. Livestock replacement costs are as follows: Ducks - \$30.00, Sheep - \$200.00, Cattle - \$900.00. ASCA, WAV and Keepstone Farm assume no responsibility for any accident or injury.
- Substitutions allowed per ASCA Stockdog rules.
- Bitches in season will run in order. They should be crated away from trial arenas when not competing.
- All dogs must be on leash when not competing.
- Entry confirmation will be sent by email; please be sure to include your email address.
- Trial committee will draw run order prior to the trial.
- Entry fees will only be refunded if request is received before pre-entry closing date or if runs can be filled from a wait list.
