Limited Entry

Entries are taken in the order received. No priority is given to any one type of entry over another.

- 50 runs per judge, per day*
- Duck limit: 30 runs total per day
- Cattle limit: 12 runs total per day
- Course D Ranch, 10 runs per trial

Each ranch run will count as 1.5 regular runs. For every two ranch entries, the total daily limit will be decreased by one run, for a potential for only 45 daily runs per judge.

Eligibility of Dogs

Trial levels, HT and PT are open to all herding breeds nine (9) months of age or older that are registered with The American Kennel Club or have been granted an ILP/PAL and are eligible to compete in herding trials and tests under Chapter 1, Section 3 of the AKC Herding Regulations.

The Herding Instinct Test is open to all herding breeds six (6) months of age or older that are registered with The American Kennel Club or have been granted an ILP/PAL and are eligible to compete in herding trials and tests under Chapter 1, Section 3 of the AKC Herding Regulations

Farm Dog Certification

The FDC Test is designed to assess the overall conduct of a dog in a typical farm environment. The dog must demonstrate self-control when exposed to livestock and other unique sights, sounds and scents. The dog must exhibit confidence and a willingness to comply with instructions when confronted with a variety of situations. The FDC Test is not intended to confer herding ability, but rather a foundation of self-control and biddability beneficial to all working dogs.

Eligibility of Dogs

The FDC Test is open to all dogs at least 9 months of age that are individually registered with the AKC, recorded in the FSS program, dogs with PAL numbers or dogs enrolled in the AKC Canine Partners program. This information must be available at the time of testing (for day-of-show entries).

Females in season may not enter. Dogs with physical challenges (including amputees) are eligible to enter provided, in the opinion of the judge they display no signs of physical discomfort and can safely complete the test.

A dog may enter only once per event. An event is defined by an event number. *Farm Dog certification is offered at all four trials. The FDC certificate requires two passes under two different judges.*

If because of riots, civil disturbances, or other acts beyond the control of the show giving club, it is impossible to open or complete the show, no refunds will be made. Event Service Fees on herding events will be \$3.50 per entry. (*American Kennel Club Herding Regulations, Chapter 1, Section 16.*)

Notice to Exhibitors

- Bitches in season shall be eligible and will be run at the end of their level in tests, in catalog order at the trial level.
- There will be no smoking at the show site. Please dispose of trash in the proper manner. Bring shade, water and chair. Event will be held rain or shine.
- All dogs present which are not being worked in the arena must be kept quiet, off course, on leash and away from the fences. Please do not allow them to disturb the resting stock or interfere with the working dog.
- Judges are not required to wait for dogs. It is the responsibility of the owner/handler to have the dog at ringside when required and without being called.
- Exhibition Only, Instinct Test, and Farm Dog Certification entries will be offered if entries have not reached the numerical limits and as time allows. Please check the judging schedule for details.
- It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Event Committee, be asked to leave the show site. In such case, no refund of any fees paid will be made. The host club, Keepstone Farm, Clantyre Show Secretary Services and its agents, employees, etc. will assume no responsibility for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children.

Closing of Entries/Alternates and Move-Ups

(AKC Herding Rules & Regulations, Section 13):

- When trial entry limits have been reached, all additional entries received prior to the closing date will be added to a wait list. At closing, a limited number of alternates per trial will be chosen by the trial secretary from the wait list, with preference given to dogs/handlers who are expected to be on the grounds the day of the trial. All other wait-listed entries will be returned.
- Entrants on the alternates list must check in with the Herding Secretary on the grounds no later than 30 minutes before the commencement of their class.
- Entry fee will be refunded to the alternates whose dogs do not have an opportunity to run.
- Requests for move-up must be given to the Herding Secretary at least 30 minutes prior to the start of the event.

Refund Policy

- Entry fees will not be refunded in the event that a dog or handler is absent, disqualified, or excused by the Judge or Veterinarian, or barred from competition by action of the Show Committee.
- If because of riots, civil disturbances, or other acts beyond the control of the show giving club, it is impossible to open or complete the show, no refunds will be made.
- Refunds of entries pulled after closing date will be made as long as an alternate is available to replace the run; if no alternate runs, no refund will be given.
- No refund for duplicate entries or any other cause beyond the control of ABC after the closing date (Rules Applying to Dog Shows, Chapter 11, Section 6) including injured or sick dogs or handlers.
