COVID-19 INFORMATION

If either of the following conditions apply to you, please DO NOT attend this trial and contact the Trial Secretary if you wish to request a refund for any runs not yet completed:

- You were exposed to COVID-19 within the 14 days preceding the trial and do not have a confirmed negative result from testing done after the exposure.
- You have COVID-19 or any of its symptoms at the time of the trial, or feel ill in any way during the trial.

GENERAL INFORMATION

The trial will be run and judged under ASCA rules as published in the most current rulebook. Run order will be drawn in advance. Bitches in season will run in order. All non-ASCA registered dogs must have an ASCA tracking number to receive ASCA titles. See <https://www.asca.org/> or call (979) 778-1082.

Dogs must be confined or on leash at all times when not working or in a designated exercise area. Individuals are responsible for any damage done to stock and/or facilities.

Dogs that attack or maul any person, dog or livestock will be disqualified.

Stock replacement fee (injury is vet on-call fee): \$25 ducks, \$250 sheep, market value cattle.

Concessions: Food will not be available on site. Some food options are available nearby in Pinckney on M36.

SPECIAL WEEKEND AWARDS

High Combined Aussie: highest combined score from all 4 trials. *Winner will have name plate added to a club maintained trophy handcrafted by Danny Mahoney in memory of Linda Mahoney and Karen Dearden. Linda and Karen were longtime SEMASA members that worked tirelessly at our trials, enjoyed working their dogs, and were always willing to educate others about the breed and its amazing history. Their friendship and contributions to SEMASA and to the working Australian Shepherd will never be forgotten.*

High Combined WTCH Aussie: highest combined score from all 4 trials on all classes of stock to the Aussie that begins the trial with the WTCH title.

High Combined Non-WTCH Aussie: highest combined score from all 4 trials on all classes of stock to the Aussie that begins the trials not having earned the WTCH title. Scores may be earned in the Open and/or Advanced divisions.

Most Promising Started Aussie: calculated by using the two highest started scores from each class of stock in all 4 trials.

High Combined Other Breed: highest combined score over all 4 trials from any division on all classes of stock.

High Combined Open Junior: highest combined score over all 4 trials from any division (not including Novice Handler or Working Junior Handler) on all classes of stock.

High Combined Junior Handler: highest combined score over all 4 trials from the Junior Handler division on all classes of stock.

GUIDELINES FOR USE AND ATTENDANCE AT SHEEPSMITH FARM

- Before you arrive: Be sure you are feeling well.
- **Stay home if you do not feel well.**
- Assure you have a facial covering & hand sanitizer with you.
- Social Distancing: Maintain 10 feet or more from others while at SheepSmith Farm.
- Park spaced such that safe distance can be maintained around vehicles.
- Face coverings: Everyone must have a face covering on their person while at SheepSmith Farm. A face covering is required to be worn at all times for indoor activities, including the indoor arena.
- Face coverings may be pulled down in outdoor areas as long as you're at least 10 feet from other persons.
- Off-limits areas: ALL indoor areas and within a 6 ft. radius of building entrances are OFF LIMITS, unless permission is granted for entrance.
- Maintaining good hygiene: Touch points will be sanitized after each run.
- Please use hand sanitizer or wash your hands just prior to your run and after your run.

Exhibitors not abiding by these guidelines will be asked to leave the trial (no refunds will be issued).

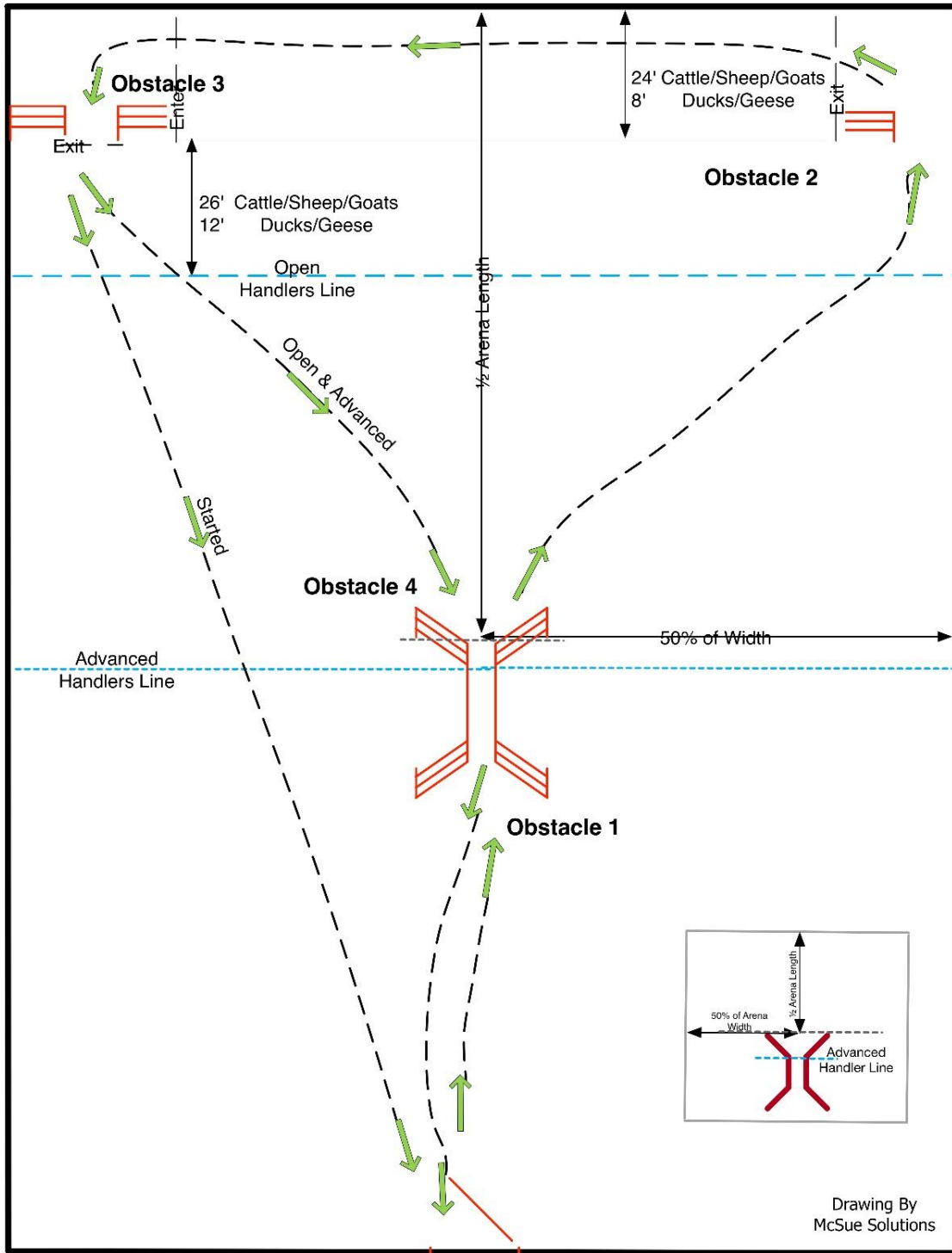

AGREEMENT

IMPORTANT LEGAL AGREEMENT—(1) The person signing this Agreement represents being authorized to enter into it on behalf of him/herself, as well as (if different) the owner(s) and handler(s) of the dog(s) for which an entry form is being submitted (all these parties collectively referred to herein as "Applicant"). (2) "Releasees" here collectively refers to the Australian Shepherd Club of America® (ASCA®); its officers and board of directors, staff, contractors, insurers, attorneys, and agents; as well as ASCA®'s affiliate clubs and each of their members, officers, directors, employees, show chairs, show committees, judges, contractors, insurers, and agents. (3) Applicant enters into this Agreement in consideration for being allowed to submit an entry form and, if approved, to take part in related activities of ASCA® and/or its affiliates. (4) Applicant acknowledges entering into this Agreement voluntarily, after the opportunity to obtain independent legal review of it and to have questions about its likely meaning answered through such review. (5) Applicant accepts the terms of this Agreement not only on his/her own behalf but also for his/her successors, assigns, beneficiaries, heirs, parents/guardians, and anyone else who might raise a claim on his/her behalf or as a result of her suffering harm. (6) To the extent any provision or application of this Agreement turns out to be unenforceable, the rest of it still remains fully effective. (7) This Agreement is to be interpreted under Texas law, without application of its choice-of-law rules, and—to the extent permitted by law—any legal action by Applicant that names Releasees as one or more defendants shall be filed and heard solely in the state or federal courts serving the county of ASCA®'s headquarters: Brazos County, Texas. (8) Applicant agrees to abide by the rules and regulations of ASCA® and any other rules and regulations appearing in the premium for this event. (9) Applicant represents that the dog(s) being entered is/are not known to pose a hazard to persons, other dogs, or property and that all required rabies and other vaccinations under the state and local law of the dog's state of residence are current. (10) Applicant acknowledges awareness of and assumes the risk associated with his/her participation and that of his/her dog(s) in this event and related activities, among which are personal injury to Applicant and those affiliated with Applicant, injury to Applicant's dog(s), and damage to Applicant's property. As but a few examples, Applicant and/or his/her dog(s) may be injured from the condition of (or failure to warn of the condition of) floors, stairways, lighting, security measures or a lack of them, electrical devices, fittings, show rings, parking areas, motor vehicles, and unfamiliar animals and people. (11) Applicant releases Releasees from any claim or liability whatsoever arising from any injury, harm, liability, or demand in anyway said to occur during or in connection with related events, also waiving any right to assert such claims that he/she otherwise might have in the absence of this Agreement. (12) Applicant also agrees to indemnify Releasees from any claim that Applicant or those acting on Applicant's behalf, for Applicant's benefit, or in Applicant's place, might assert against Releasees. The obligation in this regard extends even to Applicant's paying settlements, judgments, and expenses and costs of legal defense incurred by Releasees. (13) The waivers, releases, and promises of indemnification undertaken by Applicant in this Agreement EXTEND EVEN TO: CLAIMS ASSERTING NEGLIGENCE PER SE, CONDUCT THAT IS INTENTIONAL OR RECKLESS, CLAIMS OF FRAUD, CLAIMS INVOLVING DEATH, ACTIVITY THAT WOULD OVERLAP WITH ALLEGATIONS OF CRIMINALITY, AND/OR CLAIMS SEEKING EXEMPLARY DAMAGES. They apply without regard to the basis of the claim (e.g., based on tort, breach of contract, common law, implied or express warranty, or otherwise). Applicant's promised indemnification of Releasees also extends to claims third parties assert against Releasees said to be based on Applicant's conduct. (14) INFECTIOUS DISEASE—Applicant's promises and assumption of risks in this Agreement also extend to the risk and any asserted harm Applicant and the dog(s) may suffer from actual or threatened exposure to infectious disease, whether COVID-19 or otherwise, and Applicant accepts full responsibility for taking such measures as may be required or prudent to protect Applicant and well as other participants in the events. Applicant represents being aware of related recommend health practices, e.g., masking and distancing. (15) Applicant assigns to ASCA® the sole right to pursue any claim in connection with or arising in relation to the scheduled events that Applicant or those acting for Applicant otherwise might assert against any person or entity affiliated with ASCA®. (16) There are no provisions to this Agreement other than as spelled out here and they may not be modified except by formal ASCA® board action. This Agreement is to be interpreted to provide Releasees with the maximum protection from liability allowable under the law.
