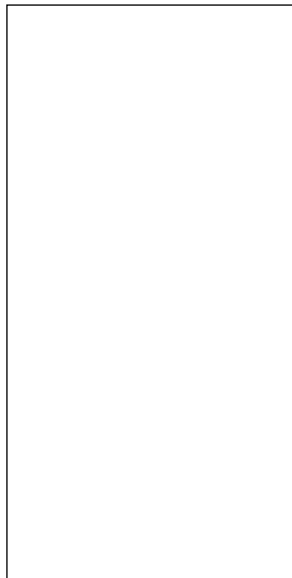

**Entries not on official AKC entry forms or photocopies without the agreement** and rules are unacceptable. Telephone, telegraph, fax, and unsigned entries cannot be accepted. Changes, additions, or corrections to entry forms must be received in writing prior to the close of entries. No refund for duplicate entries or any other cause beyond the control of the club after the closing date.

**All dogs must be held on leash,** except during tests or trials. Dogs must be kept a suitable distance away from the test/trial area. Handlers should bring water and provide shade for their dogs. Handlers are required to pick up after their dogs.
