Build a relationship with your dog, build interest, teach the dog to work calmly with stock, learn or fine-tune herding commands. Learn by watching others work their dogs. Mixed breed hair sheep, and ducks available. There are several different sized working areas, including an indoor arena.

**Registration: to hold your working spot,** please fill out the attached entry form, make check (payable to Outback Farm) mail to: Outback Farm at the address above. You will receive an email confirming receipt of registration. **Entry date for clinic opens 9/1/2019.**

**Cost:** \$110.00 per day. Auditor registration is \$50 per day. Auditors must also fill out & sign entry form. If you register for a working spot, but are unable to attend, your money will be refunded to you only if your spot can be filled.

**Restrictions:** This is a private farm, please be considerate. Please clean up after yourself & your dog. Dogs must be on leash or penned/crated when not working, and must not be allowed to bark continuously, harass the livestock or interfere with the teams that are currently working. Please follow all farm rules.

**Other:** Food: Breakfast snacks, drinks & lunch will be available during the day and supplied by the farm. Water/pools will be available for cooling dogs off. Please bring your own chairs and crates. Dress in layers & wear appropriate footwear.

## Directions:

**From the North:** Take Rt.84 to Milford, PA exit (Rt. 6 & 209 S). Follow thru Milford, turn Left onto Rt. 206 S, & go over Delaware River into NJ. Follow Rt. 206 S for approximately 20 minutes. Turn right onto Union Turnpike (Rt. 630 W), at traffic light. Take a right onto Morris Turnpike, then take first left onto Stempert Rd. & farm is #18 on the right. Split rail fencing around property.

**From the South:** Take Rt. 15 N, to Rt. 206 N. Turn left onto Union Turnpike. Take first left onto Stempert Rd. & farm is #18 on the left.
